Secretary Report:

March 2018 Board minutes yea/nay – Approved

Treasurer Report:

- VOTE \$141.31 to Always Safe locksmith for gate repair Approved
- Non-Vote Washington property tax bill for \$3.09 for storm drainage. Lorna called, LFHA is exempt, charge removed.
- VOTE Insurance bill for LFHA. \$5,649.00. Concerned about our policy stating no fishing on waterfront, when we allow fishing and if we needed to Volunteer medical coverage. Board voted to cover basic bill and allow additional cost for fishing and volunteer medical cover if not already covered. Also, policy states that we have 1 lake. Should our storm ponds be included? Loran to follow up and notify board - Approved
- Non-vote: Newspaper ad for upcoming garage sale. Brief discussion is a newspaper ad necessary with all the social media that is available? Board will reimburse cost of newspaper ad.
- VOTE reimburse \$49.78 to Nancy F. for candy purchased for the LFHA Easter Egg hunt. Approved
- When to do the Reserve Study. Board decided to go ahead with scheduling the Reserve Study site visit and pay the up front cost (1/2 of \$1460.00.) Jeff H. and Chase want to be there for the site visit.
- When do we waive the CPA audit for 2017 books? Last month board had discussed doing an
 electronic vote for the audit. Neither Chase nor Shantel were at this month's meeting for an
 update. Tabled until May's meeting.

 Website issues for LFHA.net. Could we do better? Problems with lock-outs of emails, slow response from website "help desk", cost of website. Lorna to ask a neighbor who works with websites to look over our website for advice.

Our Park Gate Programmer can program a 24-hour event code so that everyone attending the event can enter & leave.

- Reimburse Nancy F for candy 49.78 we didn't get many donations this year; maybe have to put more into budget to buy candy in future. I spend \$79.63 lost receipt.
